We conduct a search of his person and he is in possession of a California ID card and other property belonging to a Hispanic female who has an address in Modesto. The subject said he just happen to find the ID card. We attempt to locate a telephone number for the owner by checking with Modesto PD and they provide us with a current number. Unfortunately there is no answer so we left a message asking for a return call. He was arrested for misappropriation of property and the items were taken as evidence. He was released on a citation. Follow up is planned during business hours to confirm how he managed to come into possession of the property.
