#### **SUPERVISOR COMMENTS**

Despite Day shift only taking ten report calls for the day we were very busy. We made four trips to the jail and handled an aggravated assault involving a vehicle that tied up a lot of our time and tied up multiple officers. At one point we had over ten calls holding without officers available to send. Swing shift came on and reduced that number by at least half. Thank you Swing shift!

The aggravated assault call: At approximately 1218 hours today we received a call of a vehicle vs. pedestrian accident on Lander Av. and Highway 99. We arrive on scene and learn it was actually an aggravated assault. A witness advised she observed the suspect attempt to run over Victim # 1 by driving up onto the concrete side of the underpass of Highway 99. A Witness and Victim # 2 observed what occurred and stopped to offer assistance to Victim # 1. Victim # 2 confronted the suspect driver while on foot and he hit her with the vehicle and sped off. A separate Witness followed the suspect vehicle and Officers were able to catch up to him and stop him.

Victim # 1 ran from the scene and was located hiding in a nearby business. Victim # 2 was transported to a local hospital and sustained minor injuries. A couple of witnesses were able to positively identify the suspect and provide a statement supporting two counts of aggravated assault. The suspect was arrested and booked. ### SUPERVISOR COMMENTS

Today was the first day of our work week. We started out our day by having a quick briefing due to the amount of calls pending and calls being reported as in-progress.
