#### **SUPERVISOR COMMENTS**

Officers eased back into work and quickly started handling calls for service. We had three arrests with two of the subjects getting booked for warrants and a weapon possession charge. Officers handled a call involving a subject who had been contacted on the prior shift and was going through a mental health crisis. He barricaded himself inside his mother's home, alone. Due to criminal charges not being requested, he was not arrested and didn't meet our criteria for a 5150 W&I hold. He was contacted later during dayshift and flagged down a CSO for help. This time he was outside the home and was eventually detained for a mental health evaluation by members of the Mobile Crisis Response Team (MCRT). He resisted when officers went hands on, however, was not injured when he was detained.

Officers responded to a fight involving a juvenile and an adult male. The fight was determined to be self-defense, as the juvenile assaulted the adult. The adult however had a
