General Membership Requirements

- 1. Applicants must be at least 14 years of age (and out of the eighth grade), and have not yet reached their 18th birthday. (Explorers may remain active in the post until the end of the calendar year of their 21st birthday.)
- 2. Parental approval must be obtained.
- 3. High School transcripts demonstrating a 2.5 grade point average, or better, must be enclosed with the application.
- 4. The applicant must be in good health and without physical condition(s) that will endanger them, or another member of the Police Department.
- 5. The applicant must be of good character and possess good moral habits. Driving records will be considered.
- 6. All applicants who are accepted must obtain a Turlock Police Explorer uniform (uniform shirts and pants provided by the Department.)
- 7. All applicants must successfully pass a background investigation including, but not limited to, a criminal history records check.
- 8. All applicants must submit two reference letters written by two adults who can attest to the applicant's good character.
- 9. None of the above requirements is intended to be an automatic disqualifier. All of the above are taken into consideration when considering an applicant. If you feel that there are special circumstances that should be considered when applying, contact an Explorer Advisor.

When filling out the attached application:

- Fill in all of the blanks. If an item does not apply to you put in N/A.
- Give complete information, including your first, middle, and last names completely spelled out.
- Submit only information you are sure of.
- Be sure that you and/or your parents sign the forms in the appropriate places.
- Intentional withholding of information or falsification of information on this application will result in immediate denail of acceptance. If the applicant is accepted and falsification is discovered, the Explorer will be dismissed without recourse.
