### SUPERVISOR COMMENTS

Dayshift had a productive day. Officers were once again kept busy for a majority of the shift. During the day officers arrested two people in two different court order violations. During one of them, officers contacted a suspicious vehicle and encountered two subjects inside. During a warrant check, it was discovered that one of the subjects had two current court orders that barred him from any contact with the other subject in the vehicle. Officers also responded to a disturbance at a residence. One of the parties was having mental health issues and was arguing with the rest of the household. While he did not meet the criteria to be placed on a mental health hold, he was intoxicated enough to be arrested for drunk in public. During the call, he decided to walk outside onto the front lawn and confront the officers. He was promptly arrested and taken to jail.

## SUPERVISOR COMMENTS

An officer investigated a call that was reported as a robbery at a local park. The victim reported he was attacked by two males who kicked him with steel toe boots several times. The victim sustained significant injuries from the assault, but the officer determined nothing belonging to the victim was stolen. Officers identified both males who were father and son, and attempted to contact them at their residence. There was no answer at the door, at this time both males are wanted for arrest for felony battery. An officer was doing extra patrol at a church due to complaints of homeless people causing issues during the night. The officer contacted a male on the property who was an arson registrant and on parole. A search of the male revealed he was in possession of 2 lighters. We attempted to contact several parole agents in attempt to get a parole violation but we were unable to get someone to answer their phone. The male was arrested and booked for trespassing.
