



# Recreation For All Scholarship Program 2022/2023



## General Information

The Recreation For All Scholarship Program is for any youth/senior individual wishing to participate in a City of Turlock Recreation Division. This program is funded by the Community Development Block Grant (CDBG) and other funding sources.

Approved applicants will be eligible for a maximum award of \$1,000.00 (pending availability) per fiscal year (July 1 – June 1) to be used as stated above. Recreation scholarships will be granted to pay up to 100% (pending availability) of the registration fees for programs that cost \$30.00 and above. Participants will be required to pay the remaining percentage, if any, at the time of registration. Applications are accepted July 2022 through June 2023. Only one application per household.

## Eligibility Requirements

- Must live within the city limits of the City of Turlock (provide a copy of a utility bill along with a picture ID).
- Be 18 years of age or under or 62 years of age and above (must provide birth certificate for each child/senior).
- Show proof that the household income is at or below 80% of the current HUD guidelines (Current pay check stubs for last 2 months, unemployment, worker’s compensations, social security, state disability, child support, spousal support, alimony, any earned income, etc.). If no income, must provide a Statement of Earned Income from Social Security Office or sign a Declaration of No Income statement from our office.

## Recreation For All Scholarship Program Checklist

- Proof of Residency
  - Utility bill
- Rental Agreement or Mortgage Statement
- Valid California Picture ID for Applicant and all persons living in the same household 18 years of age and over. Household is defined as ALL individuals living at the residence regardless of relation.
- Aid for Dependent Children/General Assistance
  - Paperwork, income verification from Social worker
- Gross Income (for all household members 18 years of age and over). Household is defined as ALL individuals living at the residence regardless of relation.
  - Current check stubs (for the last 2 months), disability, or social security earned income statement from Social Security office. All members over the age of 18 have no income we must have their Statement of Earned Income from the Social Security Office or sign a Declaration of No Income obtained in our office. If a full-time student you must show proof from school attending.
  - If self-employed, Tax returns for the previous 3 years which includes Schedule C, showing income from operations of the business and 3 months of most current bank statements.
- Dependent Verification
  - Birth Certificate or Tax Return Form
  - For Foster Care Children, please provide the Foster Care Agreement
