Their scope of services, up to the 30% stage of design development, includes, in general, pavement cores and soil sampling, pavement design, LiDAR processing, supplemental field survey, boundary surveys for monument preservation and right of way verification, utility coordination, driveway access management, evaluation of General Plan and Active Transportation Plan (ATP) requirements, funding applications, development of 30% Plans, public outreach, and Council presentations.
