- B. <u>Conference with Legal Counsel Existing Litigation</u>, Cal. Gov't Code §54956.9(d)(1)
  *"For purposes of this section, litigation shall be considered pending when any of the following circumstances exist... Litigation, to which the local agency is a party, has been initiated formally."* Name of Case: James v. City of Turlock, Stanislaus County Superior Court Case No. 9000681
- C. <u>Public Employee Performance Evaluation</u>, Cal. Gov't Code §54957(b)(1) "Subject to paragraph (2), this chapter shall not be construed to prevent the legislative body of a local agency from holding closed sessions during a regular or special meeting to consider the appointment, employment, evaluation of performance, discipline, or dismissal of a public employee or to hear complaints or charges brought against the employee by another person or employee unless the employee requests a public session." - D. <u>Conference with Legal Counsel Initiation of Litigation</u>, Cal. Gov't Code §54956.9(d)(4) "For the purposes of this section, litigation shall be considered pending when any of the following circumstances exist... Based on existing facts and circumstances, the legislative body of the local agency has decided to initiate or is deciding whether to initiate litigation. Potential Case: (1 case)
- E. <u>Conference with Legal Counsel Anticipated Litigation</u>, Cal. Gov't Code §54956.9(d)(2) "For the purposes of this section, litigation shall be considered pending when any of the following circumstances exist... A point has been reached where, in the opinion of the legislative body of the local agency on the advice of its legal counsel, based on existing facts and circumstances, there is a significant exposure to litigation against the local agency." Potential Case: (1 case)
