- A. Staff are updating the Adopt-A-Park applications and reaching out to current groups for interest in their adoption. Staff will be advertising the Adopt-A-Park program through social media once all updates are done.
- B. Columbia Pool is projected to open in April. A date has not been determined yet but once there is a date, the Parks, Arts and Recreation Commission will be notified as well as the public of the grand opening and any events that comes with it.
- C. Park rental season started on March 1<sup>st</sup> and end on October 31<sup>st</sup> of 2025. The parks requiring reservations include Donnelly Park, Crane Park, Broadway Park and the Pedretti covered picnic area. The lettered areas require reservations at these parks whereas the numbered areas are first come, first serve. All reservations are online through Community Pass and customers can reserve at home on their account or through our front office.
- D. Tournaments at the Pedretti field are occurring every weekend until November 2025. The Sports Complex currently has approximately 8 scheduled tournaments this year.
- E. Concessions at Pedretti is in full effect with an experience concessioner, who has been operating at Pedretti since mid-February 2025. He is operating the concession during games and tournaments and is doing well and gives great support to the facility.
