- 1. REZONE 2013-03, PLANNED DEVELOPMENT 270, VESTING TENTATIVE SUBDIVISION MAP 2013-01 (MONTE VERDE SUBDIVISION) The applicant is proposing to subdivide two parcels totaling 17.84 acres, located in the North West Triangle Specific Plan area, into 109 single family residential lots. The property is designated Low Density Residential in the Turlock General Plan and zoned RL-4.5, allowing a minimum lot size of 4,500 square feet and a residential density ranging between five (5) and seven (7) dwelling units per acre. The proposed lots will range in size from 4,500 to 12,170 square feet. The applicant is requesting a Planned Development to allow for the sound wall proposed along the western portion of Countryside Drive to be setback four (4') feet from the existing ten (10') foot sidewalk. The subject sites are 2531 W. Tuolumne Road, Stanislaus County APN 88-02-05 and 2750 Countryside Drive Stanislaus County APN 88-02-65. A "Mitigated Negative Declaration" is proposed.
