Avenue, Turlock: Proposed construction of a 100-foot tall monopole communications facility with mounted antennas, a 204 square foot equipment shelter, a standby 30KW generator with a 132 gallon fuel tank, and supporting equipment on a 50' x 50' leased areas of a 17.13 acre parcel. <u>View Item</u>

2. STAFF APPROVAL PERMIT 2014-05 MAR ADDAI CHURCH – LARSA BANQUET HALL, 2107 E. Monte Vista Avenue, Turlock: Proposal to legalize three existing modular structures utilized to store event supplies, such as tables and chairs, with no electrical connections, in a location currently occupied by 22 parking spaces, adjacent to a retention pond, on a 9.6 acre parcel approved under Use Permit 2002-21 for the construction of a church, multi-purpose building and single family dwelling. View Item

Anyone who is dissatisfied with the action(s) of the Planning Commission may file an appeal within <u>**TEN (10)**</u> <u>**DAYS**</u> following the decision of the Planning Commission. The appeal must be written and filed with the Turlock City Clerk. Appeal Application Forms are available in both the City Clerk and Planning Division Offices, 156 South Broadway, Turlock. There is a \$125.00 filing fee for the Appeal Application. If an Appeal Application is filed, a Public Hearing will be scheduled by the City Council to consider the appeal.
