## NONCONSENT ITEMS

These items will be individually discussed and reviewed in detail.

- 1. **VESTING TENTATIVE SUBDIVISION MAP 2014-01 (Traditions 6)** The applicant is proposing to subdivide a 2.2 acre parcel, located in the North Turlock Master Plan area, into 15 single family residential lots. The project will be developed in accordance with the RL (Low Density Residential) zoning district standards allowing a minimum lot size of 5,000 square feet and a residential density ranging between three (3) and seven (7) dwelling units per acre. The subdivision will be required to annex to a Community Facilities District to mitigate the ongoing costs of public services. The property is located at 2920 Sandstone Street, more particularly described as Stanislaus County APN 087-026-003. A "Mitigated Negative Declaration" is proposed, declaring that the project will not have a significant effect on the environment, incorporating mitigation measures identified in the Initial Study, and subject to the appropriate conditions of approval.

- 2. MINOR DISCRETIONARY PERMIT 2014-01 (Taco Bell) The construction of a 2,106 square foot drive-thru restaurant on an approximately 1.27 acre site. The site is located in the Northwest Triangle Specific Plan area. Associated parking, landscaping and paving will be installed on the site. The sign program is also included in this application. A double sided, internally illuminated 13' tall 5' wide

monument sign is proposed as well as 103 square feet of wall signs. The project is located at 3606 N. Golden State Blvd, more particularly described as Stanislaus County Assessor's Parcel No. 087-030-008. A "Mitigated Negative Declaration" is proposed. The "Mitigated Negative Declaration" states that the project will not have a significant effect upon the environment because of mitigation measures applied to the project.
